

LIMITED REVIEW REPORT

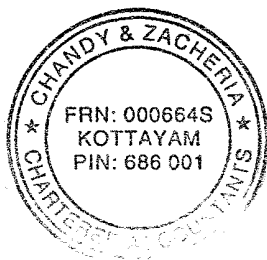
